UPPER GWYNEDD TOWNSHIP ANNOUNCES A REAL ESTATE TAX INCREASE FOR GENERAL PURPOSES AND A SEWER RATE INCREASE FOR 2014

Following an extensive Budget review process for the calendar year 2014, the Upper Gwynedd Township Board of Commissioners' announces that a general purpose tax and sewer rate increase is unavoidable. These increases follow 23 years of holding the line and/or reducing general purpose real estate taxes. The Township has also sustained and will continue to maintain very competitive sewer rates.

It is important for property owners in Upper Gwynedd to understand recent real estate tax history in our community. The last increase of real estate taxes for general purposes imposed by the Township was in 1991. The 1991 increase was followed by a 0.491 (2001) mill real estate tax reduction for general purposes. For the calendar year 2014 there are a number of budgetary demands that require that the Township increase general purpose real estate taxes from the current 0.874 mills to a 2014 proposed millage of 1.874. The proposed 2014 millage will affect the average residential real estate taxpayer by increasing their annual real estate tax levied by the Township by approximately \$142.00. It is very important for taxpayers to understand that the Township does not control the tax levy imposed by either the North Penn School District or the Montgomery County Board of Commissioners. In 2013, the Township real estate tax represented only 3.8% of your total annual real estate tax bill while the School District's tax represented 84.5% and the County tax represented 11.7%. Residential taxpayers can reduce the Township's increase by taking advantage of the 2% discount payment period and the Homestead Exemption. The Township continues to maintain the \$30,000 Homestead Exemption which benefits taxpayers by reducing the assessed value on owner occupied residential properties. Upper Gwynedd Township is one of only eight municipalities in Montgomery County offering this exemption.

The proposed 2014 budget is being presented following an exhaustive line item review resulting in significant budgetary cuts. The Board of Commissioners does not want to further reduce the budget as doing so would compromise the level of services provided to our residents. There are no proposed changes to the millage for Fire Company purposes. The following items are the significant factors forcing the Board of Commissioners to make this very difficult decision:

1. Real estate sales still remain well below 2008 levels resulting in reduced real estate transfer tax receipts. This reduction in revenue equates to 0.26 mills or approximately a \$400,000 annual reduction in receipts since 2008.
2. The cost associated with providing the current level of Public Safety services mainly due to Police coverage equates to 40% of the General Fund Budget.
3. The impact of the Affordable Healthcare Act (Obamacare).
4. The cost of implementing unfunded federal and state mandates. Most notably the cost of implementing the USEPA and PADEP mandated MS-4 stormwater management requirements. The Township did sustain a \$30,000 reduction in revenue from the Commonwealth in the form of recycling performance grants. This was caused by a statewide recalculation of the recycling grant program.
5. Low interest yields on the Township reserve funds. These returns are limited by interest rate market conditions and the investment limitations imposed on municipalities by the Commonwealth of Pennsylvania law.
6. General operating cost increase with a particular emphasis on materials, equipment, and supplies.
7. The Township must maintain reasonable fund balances in order to preserve sufficient funds to cover unanticipated expenses and to maintain the Township's Bond rating. The Township's Bond rating was recently rated as an excellent AA+ /Stable by Standard & Poor's. *(continued on next page)*

TAX INCREASE

With the proposed increases in taxes, the Township of Upper Gwynedd will continue to maintain one of the lowest municipal real estate tax levies in Montgomery County. The Township Board of Commissioners pledges to continue to provide what it believes to be a high level of service in all departments of the Township.

With respect to the proposed increase to the 2014 sewer rates, a 15% increase will be applied to all customer classes resulting in a residential increase of \$48.30 per year. This increase is justified by the following increases in cost:

1. USEPA and PADEP mandated capital expenditures taking place in both the Township's Collection System and its Wastewater Treatment Plant.

2. Increases in operating cost associated with these mandates. These costs relate to manpower, utilities, and chemicals.

3. The maintenance of the capital reserve for future Treatment Plant requirements.

With this increase the Township continues to maintain very competitive sewer rates based on a regional comparison.

Once again, the Board of Commissioners takes these decisions extremely seriously and assures tax and sewer rent payers that it continues to attempt to operate the Township in a cost effective and efficient manner. ❁

TIPS FROM THE FINANCE DIRECTOR

Save on Township Real Estate Taxes

Upper Gwynedd Township is one of a few communities in Montgomery County which offers a Homestead Exclusion on Township real estate taxes. This exclusion enables qualified property owners to benefit from a reduction in their Township real estate tax through Act 50 of the Commonwealth of Pennsylvania. To qualify for the Homestead Exemption, the property must be the owner's primary residence and be owner-occupied. Currently, Upper Gwynedd is offering a \$30,000 exemption on the assessed valuation of the property. For example, qualifying property owners whose property is assessed at \$200,000 would pay Township real estate tax on \$170,000 of the assessed valuation. **Those individuals who have already enrolled in the Homestead do not need to reapply.** If you have not previously applied, you must do so on or before March 1st in order to qualify for the exemption in the subsequent years' tax bill. For example, applications which are received on or before March 1, 2014, will qualify for a reduction in the Township real estate for 2015. Applications are made to and are approved by the Montgomery County Board of Assessment Appeals. **Applications are not to be submitted to Upper Gwynedd Township.** The Application is available on the Township's website under the resources header "Documents, Forms & Permits" link. Copies of the Application are also available at the Upper Gwynedd Township Administrative Office, One Parkside Place, North Wales. More information concerning Act 50 is available at the Montgomery County website www.montcopa.org (search for Act 50). Please follow the instructions after the Application on how to fill out the form and where to submit it to the County.

Credit cards are now accepted

Upper Gwynedd Township is now accepting credit card payments for most Township services, except taxes, in person at the Township Building. Currently, online payments are being accepted for sewer utility fees. Upper Gwynedd Township has entered into an agreement with National Payment Solutions (NPS) and MuniPAY to provide a secure means to accept credit cards as an additional payment option. NPS is a registered Merchant Services Provider and Third Party Processor that processes more than 3 billion dollars in electronic payments per year. NPS is a certified Level 1 Payment Card Industry – Data Security Standards (PCI-DSS) Service Provider. NPS and MuniPAY meet all PCI-DSS guidelines and requirements providing the secure storage and transmission of cardholder data. When selecting the online payment icon the payee will be routed to the NPS/MuniPAY secured portal to complete the transaction. This ability has been setup to give residents the convenience of paying from any location 24 hours a day. Please be advised that payments made by credit card will be charged a convenience fee of 2.45% or a minimum of \$3.00. Payment made by an E Check will be charged a flat fee of \$1.50. These fees go directly to NPS/MuniPAY who processes the transactions. These fees are not retained by the Township. Currently, the Township has made online payments available for only Sewer Rental bills – please visit www.uppergwynedd.org if you are interested in using this service. The Township will expand online payments to other Township Services such as Parks & Recreation programs in the near future. The Township wants this service to be a positive experience for all residents, and the Township Staff understands that there is no substitute for personal service. Please feel free to call or visit during business hours 8:00AM to 4:30PM, Monday through Friday, for assistance. ❁

East Interceptor Construction Project Update

Upper Gwynedd Township and its contractor, Doli Construction, recently achieved substantial completion on the East Interceptor Capacity Increase Project located along portions of the Haines Run – a tributary to the Wissahickon Creek. The \$475,000 project was completed as part of the Township's ongoing efforts to rehabilitate the sanitary sewer system and improve the water quality in local streams. The project included obstructive tree and brush removal along the existing sanitary sewer easement, the installation of approximately 2,000 linear feet of new 16" PVC pipe, 13 new water-tight manholes, 5 sanitary sewer stream crossings, and restoration of the permanent and temporary construction easements. Final restoration and selective landscape planting on impacted properties that abut the easement will be completed in Spring 2014. The Township would like to thank the abutting property owners and neighborhood residents in the project vicinity for their cooperation and patience during construction. Due to this cooperation, the project was completed on-time and under budget. This new portion of the Township's sanitary sewer system is very important in addressing the Township's existing and future sanitary sewer capacity needs. ❁

From the Chief of Police

The Ordinance for solicitor's permits has been updated. Any person who peddles or solicits for business in the Township is now required to pass a more comprehensive background check and visibly wear a photo ID attached to the permit. However, non-profit, religious, and political groups or individuals are exempt from the permit requirement. If you have any doubts about a solicitor at your door, please do not open your door. Never hesitate to call 9-1-1 to report suspicious activity. Even if you do not think it is an emergency, please call immediately. Remember it is important to lock your vehicle and home doors to help prevent crime. ❁

From the Fire Marshal

With the Winter Season upon us, residents need to make sure that they have a properly working Carbon Monoxide (CO) Detector in their residence. While CO is always present in some form throughout the year, the cold season brings a greater risk for CO poisoning, as various heating devices are used in the home. If you have a fireplace, insert, wood or gas stove, please ensure that the chimney flue is cleaned annually and that all connections are checked for security. Ideally, a CO Detector should be placed on each level of the home, and the unit should be tested each month. CO Detectors DO NOT last forever; they should be replaced every 7 years. If purchasing a new unit, one that plugs into a wall socket and also has a battery backup is recommended. For more information on Carbon Monoxide safety, please visit: <http://tinyurl.com/cescmal>.

Upper Gwynedd Township recently adopted the 2009 Edition of the International Fire Code. With the adoption of Ordinance 2013-010, the Fire Marshal's office will begin conducting Fire and Life Safety Inspections beginning in early 2014. These inspections will occur in all commercial occupancies within the municipality. The purpose of these inspections is to ensure establishments in Upper Gwynedd are operating facilities that are up to today's safety standards, and that their engineered safety systems are being maintained. It is anticipated that there will be an 18 month cycle to complete all of the buildings in the Township. Further information for business owners will be forthcoming. 🌿

Friday sessions are from 7-9pm and Saturday from 11am-2pm. Parents must be present at walk-in registration and proof of name and date of birth documentation must be provided for all new players. ZONING UPDATES

The following Standards and Regulations must be followed in order to ensure the safety and high quality of our neighborhoods.

Signs on Residential Properties

Homeowners, please remember that contractor signs are permitted only while the work is being performed, never longer than 30 days, and must be removed immediately upon completion of the activity. These signs are not permitted within the legal right-of-way of a street or within the clear sight triangle formed by the intersection of two streets, or a driveway with a street. Signs within the legal right-of-way or clear sight triangle present a safety hazard and will be removed by Township personnel.

Business Owners You may display signs for special events, grand openings, and the like, but you must first obtain a Permit and disclose the number and size of signs based on the sign code. These signs shall not be placed within the legal right-of-way of a street or clear sight triangles discussed above. These signs are not permitted for more than 30 days per calendar year.

Fences All new or replacement fence installations require a Permit. The property owner is responsible to ensure that the fence does not cross a property line or block an

easement. Fences must be set behind the legal right-of-way of a street and may not intrude into the clear sight triangle formed by the intersection of two streets or a driveway with a street. The maximum height for a fence in a residential or commercial district is six feet, in an industrial district the height may be eight feet.

Swimming Pools Permits are required. The owner or pool contractor must submit a survey plan prepared by a licensed surveyor or engineer. All grading and construction activities must comply with current codes for electrical, structural, and child safety barriers. In order to ensure that plans are properly followed, regular inspections must occur as indicated by the Permit.

New Updated Zoning Map

A new colorized and electronic Zoning Map is near completion and once adopted by the Board of Commissioners will be posted on the Township website. This should help interested owners/buyers/appraisers to view the zoning of a particular property without having to call the Township or purchase a separate hard copy map. The Township expects this to be posted in February or March, 2014. 🌿
